My Brothers, I wish that I could compassionate your spirits today, if yours feels as troubled as mine. I have no words to salve the pain of war, I only know that we can pray for peace, and we can each work with kindness and forbearance toward a better life for all mankind.

KING SOLOMAN'S CHAIR - THE ROLE OF LODGE MASTER

St. John's continues to provide a program of Masonic Education as the focus of our stated communications in 2022. While the Chamber of Reflection, which Bro. Kemal Alaeddinoğlu explored fully in January is not technically a part of the initiatory degree, we find that it encourages the candidate to reflect on his previous life experience and prepares him for his next step on his journey. Last month we examined the Preparatory Lecture as WBro. Russ Johnson parsed it sentence by sentence, promising to offer the candidate moral and philosophical instruction after first entering the Lodge portals.

This month one of our Past Masters, MWBro. Al Jorgensen, will discuss the duties, responsibilities and privileges of the Master of a Lodge.

According to the Grand Lodge of Maine, the Master "shall have power to convene his Lodge whenever he deems it proper; to issue, or cause to be issued, all summonses or notices which may be required; discharge all the executive functions of his Lodge; and perform all acts, by ancient usage proper to his office, which are not prohibited by the Constitution and Regulations of Grand Lodge.

"It shall be the duty of the Master to preside at all meetings of the Lodge; confer or have conferred all degrees in strict accordance with the ritual which has been, or may hereafter be approved by Grand Lodge; give, or have given, in full, the lectures appertaining to each degree, at the time it is conferred in accordance with the ritual; appoint those officers as provided for in the Bylaws; attest, at each Stated Meeting of the Lodge, all minutes or records of proceedings as approved at such meetings by the Lodge; superintend the official acts of all the officers of his Lodge and to see that their respective duties are properly discharged; carefully guard against any infraction, by the members of his Lodge, of its own Bylaws, or the Constitution and Regulations of Grand Lodge; and provide for the election of his successor.

"It shall be the duty of the Master to prepare the Lodge's Annual Program; to prepare the Lodge's Annual Budget; to prepare the Master's Trestleboard articles; to appoint the Investigating Committee brethren as required; to be responsible for all Lodge committees; to attend Grand Lodge and vote the Lodge's recommendations on the resolutions; to prepare an agenda for each Stated Meeting; and to appoint the ... committees for the Lodge.

"The Master is to be qualified to give the work and to give, or arrange to be given, lectures of the First, Second and Third Degrees; and to be thoroughly proficient in those portions of the Constitution and Regulations of the Grand Lodge which relate to the government of a Lodge. He is to learn the ritual for conducting Stated Meetings; to learn the ritual for receiving Grand Lodge representatives (District Deputy, Grand Master, etc.); to conduct Memorial Services; to conduct degree practices for all officers of the Lodge; to notify the Secretary of the date of initiation for newly elected candidates; to take charge of all Third Degrees; to attend Schools of Instruction; and to arrange for new Master Masons to give their lessons in open Lodge."

In addition to this discussion of the Master of the Lodge, Bro. Ken Woo will speak on the Importance of Aprons.


Junior Warden's Message WBro. Eric Koteles

The Holy Book must be opened upon the altar before a Masonic Lodge may be opened. The V.S.L. is, therefore, a symbol of the revealed will and teachings of the Great Architect of the Universe - a name under which any Freemason can worship that Deity in Whom he puts his faith and trust.

Freemasonry Is Not Fast Food

Last week I attended a meeting of a Lodge that takes Freemasonry seriously. Extremely seriously. They are what I would consider to be an Observant Lodge. For example, over the course of many years they have



dissected every aspect of the Degree Experience, working to infuse meaning into every single detail. From the moment that a man is informed that they have elected to give him the Degrees of Masonry to the Charge, every detail is carefully crafted and finely tuned.

Last week I also attended a Masonic meeting that was to the casual observer, the direct opposite. It was marked with laughter, storytelling, a copious amount of alcohol (it was not a Stated Meeting, nor did it take place within a Lodge room) and a great deal of frivolity. These men focus on building bonds of Brotherhood within their Lodges, and on hyper local but extensive charity in their community. Stated Meeting or other event, either way, a visitor to this group will have a superb time and quickly build friendships.

These two groups are as different from each other as our sun and moon.

Yet they are both practicing Freemasonry.

Having spent time with each of them, I would argue that they are both practicing Freemasonry extremely well. That they both serve as shining examples within our Craft. I admire both of these groups, and I have friends within each of them.

Yet they are both radically different in their approach to our sacred institution.

And that is perfectly OK.

In fact, that is a good thing.

What speaks to one man will not necessarily speak to another man. What one man finds interesting will not necessarily be interesting to another man. What one man considers to be vital will seem trivial to another.

Men are unique unto themselves.

As such, what might be one Man's ideal Lodge might strike another man as an absurd assemblage.

This is why diversity in the character and personality of Lodges is so important. This diversity allows that every man can find a Lodge that suits him, assuming that he is willing and able to travel if need be.

I think that there is a bit of a drive for uniformity within Grand Jurisdictions around the United States. I imagine that is quite understandable in this land of chain restaurants where one's hamburger and fries ordered in Seattle will taste exactly the same when ordered in Miami.

Perhaps the clearest example of this in Washington is the Standard Work. Work that no man save the sitting Grand Master is allowed to perform with any deviation whatsoever. That's OK. It is our Work, adopted, refined, and perfected over generations. It is a good thing.

But I think, as with all good things, uniformity is best when taken in moderation. We do not want a Grand Lodge that dictates everything to Lodges. We do not want our Lodges to all be exactly the same, with as little deviation from each other as are fast food outlets within a single chain.

We want the Lodge that takes the ritualistic aspects of Freemasonry so seriously that they become famous for it, and we want the Lodge that becomes equally famous for the hearty and hale bonds of Brotherhood it creates within men.

We want both these Lodges, and a myriad of Lodges in between them, for in that way, and in that way alone, will we have at least one Lodge that can resonate with and be important to, every good man.

MWBro. Carl B. Smith 1936 – 2022

It is with great sadness that we report that Most Worshipful Brother Carl B. Smith has passed to the celestial Lodge. Memorial services will be held Sunday, March 27, 2022 – 1pm - Nile Shrine Center. Most Worshipful Brother Carl Bernard Smith was born in Seattle on January 30,1936. He attended public schools there until the family moved to Nome and later Kodiak, Alaska, when his father was transferred. Carl graduated from Kodiak High School at the top of his class. He then enrolled in the University of Washington and graduated in 1958 with a Bachelor's Degree in Civil Engineering.

He would immediately join the Boeing Company where he was employed as a Weight Engineer. He was subsequently promoted into Weights Engineering management, where he remained until his retirement on October 1, 1994. He served as the Weights Engineering

Manager through the original development of the 767 and 777 airplanes now used throughout the world. His 37-year career was exemplary.

Shortly following graduation from the University, our brother met Barbara Jean Ray, and they were married in the following months. They have been blessed with two sons, Duane and Barry, who served as Master Councilors of their DeMolay Chapter; and a daughter, Brenda, who served as Worthy Advisor of her Rainbow Assembly. He and Barbara also enjoyed five

grandchildren and one great grandson.

Our Past Grand Master comes from a Masonic family. His sister, Lois, is a Past Grand Royal Matron, Order of Amaranth of Washington. His father was a 30year member of Northern Light Lodge No. 279, the Lodge into which our Brother was initiated on January 9, 1975. He progressed through the offices of this Lodge and Walter F. Meier Lodge of Research No. 281, and served with distinction as Worshipful Master of both of these Lodges in 1983 and 1995, respectively.

His service to Grand Lodge began in 1984 when he was appointed to the Long Range Planning Committee. He served continuously on numerous committees, then as Deputy of the Grand Master in District No. 4, Grand Lecturer, and Grand Marshal, until June 1995 when he was elected Junior Grand Warden. He would progress through the elected line in the usual fashion, being elected Grand Master at the 1998 Annual Communication.

Most Worshipful Brother Carl chose "Let Our Light Shine" as his theme. Specifically, to let the light of Masonry shine so as to increase the visibility of our Craft. To quote from his message: "There appears to be a realization that growth comes from the inside and not the outside and that when we expand who we are, we'll no longer have to accept what we've got. When we 'Let Our Light Shine' our world will expand and society will see



that Masonry's purpose is to make men better and thereby make this world a better place in which to live."

The Brethren and Grand Lodge Team members will remember Most Worshipful Brother Carl as a Grand Master who was always well organized. PLAN was his "four letter word." It was most important to him to assure that his year as our senior management leader be fully and carefully planned so as to enable the accomplishment of the numerous objectives he had established for himself and this Grand Lodge.

During his term as Grand Master, it was his special honor to preside when both sons and his son-in-law. Jack Berryman, became Master Masons during the One Day Conferral Program.

His leadership qualities, well-honed during his professional career, enabled the Grand Lodge to progress significantly. His strong interest in the Masonic Retirement Center and his devotion and dedication to the residents drove him to work especially hard on their

> behalf. The pleasant and humorous manner in which he always conducted himself when visiting Lodges, presiding over cornerstone ceremonies or District meetings, or just having a conversation with a Brother is legend. His proud and unselfish dedication to our Fraternity, the Brethren, and to his family clearly demonstrated his character. He was a Mason and Grand Master whose leadership is recognized and whose friendship is cherished.

Our Past Grand Master belonged to Seattle Valley of Scottish Rite and Nile

Shrine Temple, where he fulfilled several leadership roles. Coroneted a 33rd Degree Inspector General Honorary, he served as the Personal Representative of the SGIG in the Everett Valley. He is a Past Patron of Richmond Court No. 72, Order of Amaranth, and was appointed Grand Prelate, Grand Court Order of Amaranth of Washington. He is a member of Thistle Clan - Royal Order of Scotland, an Honorary Member of the DeMolay Legion of Honor, a charter member of Pacific Northwest Chapter No. 534 National Sojourners, and a member of the Heroes of '76.

Carl's theme of "Let Our Light Shine" was no doubt influenced by his community service activities. For 22 years he volunteered as a Little League baseball umpire. During these years he was Umpire-in-Chief in two league districts, officiated in the 1975 Western Regional Tournament in San Bernadino, California; and was selected to umpire in the 1985 Little League World's Series in Williamsport, Pennsylvania. He was Chairman of a Cub Scout Advisory Board and received recognition for his scouting activities. He volunteered as a DeMolay Dad Advisor for five years and was Chairman of the Adult Advisory Board for his daughter's Rainbow Assembly. He also served in the U.S. Army Reserve as an Air Defense Officer, Artillery Branch, and was Honorably discharged with the rank of First Lieutenant.

Our Most Worshipful Brother now joins his beloved Barbara who preceded him in death on March 27, 2012 – no doubt sharing a dance.

RALEIGH, N.C. (AP) — The home of a former North Carolina newspaper publisher who helped orchestrate an 1898 riot in which at least 60 Blacks were killed was removed from a list of local historic landmarks.

The Raleigh City Council voted unanimously to strip the home of Josephus Daniels of the local designation.

The change is one of several as organizations look to separate themselves from Daniels. The home sits on about 4 acres west of downtown Raleigh and Wake County land records show the property is worth \$4.1 million.

The request to remove the landmark status was submitted by Scott Murray of Scott Murray Land Planning on behalf of the Masonic Temple of Raleigh, which owns the property. The house, called Wakestone, has been home to the Masonic Temple of Raleigh since 1950.

"Simply stated, ties to the Josephus Daniels's legacy presents a dark cloud over the Freemasons/Masonic Temple of Raleigh organization," Murray said, adding that the Masons worry about the property being the site of protests and unrest.

The Masonic Temple had tried to sell the property, and in 2005, unsuccessfully tried to get the historic designation lifted for most of the Lodge property.

The Raleigh Historic Development Commission voted unanimously to recommend removing the local designation in January. The property is still listed on the National Register of Historic Places. It was added in 1976.

Daniels, who was a former publisher of The News & Observer, conspired with others to instill fear and anger among the white residents of Wilmington, a majority Black town on the North Carolina coast in which both elected Black and whites worked with each other, according to the book, "Wilmington's Lie."

An armed mob descended on the city Nov. 10, 1898, killing at least 60 Black residents. The mob set fire to the black-owned local newspaper and sent thousands of Black people into hiding in swamps and woods. It has been recognized by historians as the only overthrow of an elected government in U.S. history and was referenced in the siege on the U.S. Capitol on Jan. 6.

The MSB isn't just one more bill to pay, and one more box to check off, but really it's Brothers helping Brothers in all the ways that we're supposed to do, and that help us each fulfill ourselves by helping others.

The Lodge work that our Brothers are most inspired to perform is work that other Brothers can speak to from the heart. Like Brockway Operation Kids Smile, which Brothers are excited to do in large part because we know that our Brothers have been personally touched to be a part of it in years past.
